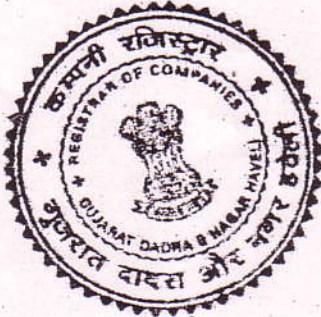

MEMORANDUM OF ASSOCIATION

OF

MACPOWER CNC MACHINES LIMITED

- I. *The Name of the Company is “**MACPOWER CNC MACHINES LIMITED**”.
- II. The Registered office of the company will be situated in the state of Gujarat.
- III. The objects for which the Company is established are hereunder:
 - A. THE MAIN OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:**
 1. To establish, own, run, take on lease and carry on in India or elsewhere the business of manufacturers, processors, assembling, importers, exporters, designers, fabricators, distributors, suppliers, dealers, consignor, consignee or otherwise deal in all types, kind, size, description of CNC (Computerised Numeric Control) Machines, CNC Turning Center and all other types of Machinery & Machine Tools.
 - B. THE OBJECTS INCIDENTAL AND ANCILLARY TO ATTAINMENT OF THE MAIN OBJECTS:**
 1. To acquire real or leasehold estate and to purchase or otherwise acquire or provide in any place in which any part of the business of the company may from time to time be carried on, all such offices, warehouses, workshops, buildings, houses for employees and directors, machineries, engines, plants and appliances as may be considered requisite for the purpose of carrying on the business of the Company or any part thereof.
 2. To acquire and undertake the whole or any part of the business, property with or without liability of any person carrying on any business which the company is authorized to carry or possession of property suitable for the purposes of the objects of the company.
 3. To apply for purchase or otherwise, acquire any patent, patent right, trademark, formulate, license, lease, concessions, conferring any exclusive or limited right to use, or any secret other information as to any invention which may seem capable of being used for any of the purposes of the company or the acquisition of which may directly or indirectly benefit the company; and to use, exercise, develop or grant licenses in respect of or otherwise turn to account the property, rights, or information so acquired.

4. To enter into any arrangement with any Government or other authority whether municipal, local or otherwise of any place, that may seem conducive to company's objects or any of them; and to obtain from any such Government or authority any rights, privileges and concessions which the company may think it desirable to obtain; and to carry out, exercise and comply with any such arrangement, rights, privileges and concessions.
5. To establish or support or aid in the establishment and support of association, institution, funds, trust and the conveniences for the benefits of past or present employees or directors of the company or defendants of such persons; and to grant pensions and allowances, to make payments towards insurance, to subscribe or guarantee money for charitable or benevolent object or useful objects for general public.
6. To form, promote, assist or aid in forming, promoting partnership, syndicate, companies and other body corporate including subsidiary companies for the purpose of acquiring or taking over all or any of the property, rights and liabilities of the company or for any other purpose which may directly or indirectly benefit the company.
7. To pay, reimburse or to give credit for charges and expenses out of the fund of the company which are incidental to the promotion, formation, registration, establishment of the company as are incurred by the promoters in his preliminary or pre-incorporation stage and or to issue shares against such expenses as may be decided by the Board of Directors from time to time.
8. To hold, use, work, manage, improve, carry on, and develop the undertaking, lands and movable estate or property and assets of any kind or any part thereof.
9. To dispose of any property of the company either absolutely or conditionally and in such manner and upon such terms and conditions in all respects as may be thought fit and to accept payment or satisfaction for the same in cash or otherwise.
10. To subscribe for, take or otherwise acquire and hold shares, stocks, debentures or other securities of any other Company having objects altogether or in part similar to those of the Company or carrying on any business capable of being conducted so as directly to benefit the Company.
11. To establish, maintain and conduct subsidise research, laboratories and experimental workshop for scientific as well as technical research and experiments and undertake and carry on with all scientific and technical research experiments and tests undertaken to promote studies that may be considered likely to assist any of the business which the Company is authorised to carry on.
12. To vest any movable or immovable property right or interest acquired by or belonging to the Company in any person or company on behalf of or for the benefit of the Company with or without any declared trust in favour of the Company.

13. To guarantee the payment of money secured or unsecured by or payable under in respect of promissory notes, bonds, debentures, debenture-stock, contracts, mortgages, charges, obligations, instruments, of any person whatsoever, whether incorporated or not and generally to guarantee or become securities for the performance of any contract or obligation.
14. To take part in the management, supervision and control of the business or operation of any company or undertaking having similar objects and for that purpose to appoint and remunerate any directors, trustees, accountants or other experts.
15. To amalgamate, enter into partnership or into any arrangement for sharing or pooling of profits, union of interest, cooperation, joint venture or otherwise with any person, firm or company carrying on or engaged in or about to carry on any business or transaction which may seem capable of being carried on or conducted so as, directly or indirectly to benefit the Company.
16. To acquire or dispose off any concern or undertaking, patents, licenses, securities, concessions, policies, book debts and claims, any interest in real or personal property and any claims against such property or against any person or mortgages, charges, annuities for certain period or on deferred basis.
17. To acquire from and/or give to any person technical information, know-how, processes, operating data, blue-prints useful for the design, erection and operation of system required for any of the businesses of the company and to acquire any grant or licenses and other rights, privilege and benefits.
18. To appoint arbitrators and to refer to arbitration, institute, defend, compromise, withdraw or abandon any proceedings whether legal or otherwise and claims by or against the company, its officers, its agents, sub-agent or otherwise concerning the business and affairs of the company.
19. To carry on the business of developing, designing, producing, distributing, trading and dealing in computer software, hardware, info ware, and to engage in information & data processing, resource enterprising and training in computer software, hardware and information management activities.
20. To acquire, purchase, start, run, erect and maintain land, buildings, factories, equipment, machinery, computers or branch office, industrial undertaking of any kind.
21. To carry on in India or elsewhere business of on-line trading of the products of the company and other software relating to business of the company.
22. To take such steps as may be necessary to give the company the same rights and privileges in any part of the world as are possessed by local companies or partnership firms of a similar nature.

23. To apply for tender or acquire any contracts, subcontracts licenses and concessions for or in relation to the objects of business and to undertake, execute, carry out, dispose off or otherwise turn to count the same as may be thought expedient.
24. Subject to the provisions of the Companies Act, 1956, to place to reserve or to distribute as dividends or bonus share among the members or otherwise to apply any money received by way of premium on shares or debentures issued at a premium by the Company and any money received in respect of dividends accrued on or arising from the sale of forfeited share.
25. To lend, invest or otherwise employ or deal with money belonging to or entrusted to the Company in securities and shares or other movable or immovable property or without security upon such terms and in such manner as may be thought proper from time to time to vary such transactions and investments in such manner as the Directors may think fit subject to the provisions of the Companies Act, 1956.
26. To establish agencies in India or elsewhere for sale and purchase to regulate and discontinue the same subject to law in force.
27. To enter into any agreement or arrangement with any person whether in India or elsewhere for any of the objects of the company.

C. OTHER OBJECTS:

1. To carry on the business of manufacturers, importers, exporters, assemblers, hirers and repairers of and/or dealers in and marketing and distribution of computers and computer peripheral, software and hardware, computer parts, data transmission circuits, audio visual equipments and consumer electronics, radio receivers, television receivers, television picture tubes, tape-recorders, record changers, test and measuring instruments, inspection instruments, digital and analytical instruments, electronic environmental and pollution measuring instruments, photocopier machines and other office equipments, electronic desk calculators, process control systems, industrial electronics, medical electronic equipments, electro devices, audio record/play systems, closed circuit T.V., aerospace electronics, geo science electronics, broad casting electronics and for the purpose of foregoing but without limiting the generality, materials, accessories, components and spare parts thereof.
2. To carry on in India or elsewhere the business to generate, produce, trade acquire, use, transmit, accumulate, employ, distribute, develop, handle, protect, supply, deal in electric power at such place or places as may be permitted by appropriate authorities by establishment of thermal power plants, atomic power plants, wind power plants, solar power plants, hydraulic power plants and other power plants based on any source of energy as may be developed or invented in future.

3. To carry on business as agents, holders or investors in saving unit or units issued by the Unit Trust of India or other mutual funds.
4. To carry on the business of taking/giving on hire and rent all classes and kinds of plants and machineries, lands and buildings and other properties.
5. To receive money, securities and valuables of all kinds on deposit at interest or for custody and generally to carry on the business of a safe deposit vault company.
6. To carry on the business of a finance company, lease finance company and to finance industrial, commercial enterprises and to promote companies engaged in industrial, manufacturing and trading business whether in India or out of India and subject to provisions of law, receive and give short term/long terms loans with and/or without security and interest, and raise public deposits.
7. To carry on the business of travel agency and to act as tourist agents and contractor and to facilitate traveling and to provide for tourists and travelers such as buying, booking, hiring, leasing buses, taxies, ships, aircrafts, hotels, rooms, motels, out houses, cafeterias or promote the provision of conveniences of tourists.
8. To act as brokers, dealers and to carry on the business of share broking, money broking, bills purchasing, bills discounting and to advice on portfolio management, investment of money, sale of properties and to act as Registrars and Managers to the issue.
9. To carry on the business of warehousing in all its aspects in India and elsewhere.
10. To carry on any where in the world, the business of running hotel in all its aspects, lodging and boarding and to run, manage, acquire, control, own, purchase, hire the same including restaurant, café, tavern, beerhouse, refreshment-room, lodging-house keepers subject to law, wine, beer and spirit merchants, importers and dealers of aerated, mineral and artificial waters and other drinks, purveyors, caterers for public amusements, ice merchants, importers and workers of food, live and dead stock and colonial and foreign produces of all descriptions, hair dressers, perfumers, proprietors of clubs, baths, dressing rooms, laundries, reading, writing and newspaper rooms, libraries, grounds and places of amusements, recreation, sports dances and entertainments of all kinds and cigar merchants, agents for railway, shipping and airplane companies, carriers, theatrical and opera box office proprietors, entrepreneurs and general agents of things which can be conveniently carried on in connection therewith.
11. To act as trustees of any deeds constituting or securing any debentures, debentures-stock or other securities or obligations and to undertake and execute any other trusts and also to undertake the office of or exercise the powers of executor, administrator, receiver, custodian.
12. To carry on the business of advertising contractors and agents, to acquire and dispose off advertising time, space or opportunities in any media, to undertake advertising and promotional campaigns of every nature, to acquire and provide promotional requisites.

13. To carry on the business of printers, stationers, lithographers, type founders, stereotypes, photographic printers, photo-lithographers, chrome-lithographers, book-binders, designers, draftsman, paper and ink manufacturers, book-sellers, publishers, engineers and dealers in or manufacturers of above articles or things or any of them or concerned therewith.

To carry on business as manufactures, processors, refiners, formulators, buyers, sellers, importers and exporters and dealers in all types of chemicals including basic chemicals, heavy or fine, organic, inorganic, biological, laboratory, scientific chemicals, chemicals of any nature used or capable of being used in the pharmaceutical industry, agricultural chemical, fertilizers, petro-chemicals, sanitary, industrial chemicals or any mixtures, derivatives and compound thereof.
16. To carry on the business of an investment company and to invest in and acquire and hold and otherwise deal in shares, stocks, debentures, debenture-stocks, bonds, obligations and securities issued or guaranteed by any company constituted or private industrial enterprises carrying on business in India or elsewhere and shares, debentures, debenture-stocks, bonds, obligations and securities issued or guaranteed by any government, state, dominion, sovereign, public body or authority, supreme, municipal local or otherwise whether in India or elsewhere and to provide merchant banking services by acting as manager to the public issue or brokerage, loan syndication, guarantee and also to act as registrar to the issue of the companies, bodies corporate and also to carry on the business of project financing, shares and securities, financing and to act as shares and stock brokers at any place in India in consultation with the rules and regulations of various stock exchanges in India including Over The Counter Exchange of India (O.T.C.E.I.) in accordance with the guidelines framed by the securities and exchange board of India (SEBI) from time to time.
